5. The following CODE OF CONDUCT is expected from the students:
 - i. Do follow the **HALL OF RESIDENCE RULES** and **REGULATIONS**.
 - ii. You are notified that **RAGGING IS A CRIMINAL OFFENCE**. In case you become a victim or notice any such incident, report the matter to your HALL OF RESIDENCE WARDEN, CARETAKER, SECURITY or ANTI- RAGGING and ANTI-HARASSMENT Committee. Your identity will be kept strictly confidential. Please go through the Anti-Ragging Rules.
 - iii. If it comes to the notice of the management that anybody is involved in any Ragging activity either directly or indirectly, he/she will be liable to strict disciplinary action as mentioned under the guidelines of the ANTI-RAGGING and ANTI-HARASSMENT Committee of IIT Indore. You are notified that **CONSUMPTION OF ANY BANNED SUBSTANCES, e.g., CHARAS, GANJA, etc.; and, ALCOHOL IS PROHIBITED WITHIN THE INSTITUTE PREMISES**. Any violation will be viewed very seriously, and appropriate disciplinary action can be taken.
 - iv. **Students are NOT permitted to keep/use a car, motorcycle, or scooter at in the Hall of Residence or Institute premises as well as in the city**. In case of any type of accidents /mishaps resulting from such unauthorized use of vehicles, the Institute will not be held responsible.
 - v. **Students are not allowed to go out of campus between 22:00 to 06:00 hrs**. All students should return to their rooms latest by 23:00 hrs at the campuses.
 - vi. Students are not allowed to enter the under-construction building sites for any reason. If found doing so, they will be heavily penalized.
 - vii. Students are not allowed to enter the forest area.
 - viii. Students are advised not to go for a walk in the dark areas of the campus.
 - ix. **The entry to the terrace is prohibited for students.**

10. In case you are unfamiliar with **INDORE** city, do acquaint yourself from your Hall of Residence inmates properly about the rules/regulations and any risks involved before moving out.
11. Always carry your **IDENTITY CARD** while moving in or out of IIT Indore campus, which may be asked to be produced at any time by the relevant authority.
12. Transport facility between the Hall of Residences and the Institute ~~is~~ has been arranged for students by the Institute. Students **MUST** use this service.
13. A transport facility ~~is~~ has been arranged for visiting markets on Saturdays and Sundays on payment of nominal charges. In addition, a bus travelling from Simrol to Silver Springs has been provided for at 12:20 p.m. for the exclusive ~~use~~ of faculty and staff members. Students who wish to go to the Silver Springs Township or any other place within the city are not allowed to board this bus.
14. In case of an emergency in which external agencies such as police, fire-brigade, etc. ~~are~~ need to be called, the student should immediately first contact the **SECURITY, CARETAKER** or **HALL OF RESIDENCE OFFICE** who will then contact the emergency services on behalf of the Institute.
